Annual Report of the Year 2012-13

During the year 2012-13 the Institute has undertaken research studies, contributed to policy making through its training programmes on goods and services tax (GST) and brought out some publications. These are listed below:

A. Research Studies Completed

Reorganizing Tax Department for VAT Administration: A Study of North-Eastern States

The introduction of state-VAT has been one of the most remarkable achievements in the arena of States' tax reforms. This has helped the States to rationalize the then existing sales taxes in the States. Notwithstanding this landmark-switchover to VAT, organizational and procedural reforms of State taxes have not kept pace with it. As of now it leaves much to be desired. More importantly, both the organization for tax administration and operations of VAT has not been rationalized from the point of administrative cost of the department as well as the cost of collection of the taxpayers. Transparency in procedures and client services also leave much to be desired.

Deficiency in VAT administration is primarily due to the fact that presently the department is based on case specialization, against functional specialization. It is accordingly divided into divisions and circles, which are primarily activity units. Also, the individual officer is responsible for all activities related to a dealer. Hence, there is one-to-one link between the officer and the dealer in the system. This study presents a scheme of re-engineering of the tax department on the basis of functions.

The overall coverage of the study is confined to two of the North-Eastern States, *viz.* Assam and Meghalaya-- Assam, representing a better off State among the other States in the region; and Meghalaya representing a typical North-Eastern State.

The study was sponsored by the Planning Commission.

B. Training Programme conducted

One Week Advance Training in GST Policy and Administration for All the States held at New Delhi.

FPEPR has organized One-week Advance Training programme on GST Policy and Administration for the State VAT Administrators from 30th April to 4th May 2012. The programme was held at Magnolia Conference Hall, India Habitat Centre, Lodhi Road, New Delhi-110003. It was attended by 39 participants from nine States.



The course was inaugurated by Shri Ramesh Chandra, former Member-Secretary of the Empowered Committee of State Finance Ministers. The valedictory address was given by Shri P. K. Tripathi, Chief Secretary, National Capital Territory of Delhi.

C. International Seminar on Tax Reforms and Tax Administration in India

To commemorate the completion of a decade of the existence of the FPEPR an International Seminar was held at the India Habitat Centre on Saturday the 8th December 2012. It was inaugurated by Dr. C. Rangarajan, Chairman, Prime Minister's Advisory Council. More than 50 delegates from different organizations including some Finance Secretaries of the State governments, academicians from different universities, research institutes, *viz.* Indian Institute of Public Administration, the Institute of Chartered Accountants of India, existing and former Member-Secretary of the Empowered Committee of State Finance Ministers and officials of Central Government and World Bank attended the Seminar. This seminar brought together experts with research interests in the fields of tax policy and tax administration. It provided an opportunity to exchange ideas among practitioners, academicians and government policy makers. International perspective was added by the experts from different countries. The seminar was sponsored by M/s Image Public Relations Private Limited, Delhi.

F. On Going Research Studies

FPEPR is currently engaged in conducting research on the following studies:

1) Revamping State Excise Duty: Issues in Policy and Governance

This study aims at analyzing revenue productivity, rationality in structure, and administrative expediency of the tax. Also, it presents policy imperatives for reforms. With a view to analyzing the issues in governance of the tax in greater details, the study covers a sample of two States, *viz.* Maharashtra and Rajasthan. Maharashtra is selected as one among the few better performed States in terms of introducing reforms in policies and administration. Rajasthan is drawn from the group of States that need to carry out further reforms. The study is sponsored by the ICSSR.

2) Preparation of Fourteenth Finance Commission Memorandum for the Government of Meghalaya

This study is an attempt to bring together all the aspects of public finance in the State of Meghalaya. This is to prepare a State Memorandum giving all the details of tax, non-tax, expenditure, debt etc for the past, current and projected period of the to be submitted to the Fourteenth Finance Commission. The study is sponsored by the Government of Meghalaya.

3) ICT, Economic Development and Poverty Alleviation

The study presents an analysis of the role of ICT in economic development and poverty alleviation. It delves upon the earlier work done on the study of E-commerce and Economic Development—sponsored by South Asia Network of Economic Research Institutes (SANEI), and encompasses the role of ICT in areas such as agriculture, rural development, industry, health, governance, digital divide, etc. in addition to e-commerce. The study aims at presenting case studies in areas exhibiting variations in economic development in India. The study is sponsored by the FPEPR, New Delhi.

G. Grant-in-Aid from Ministry of Finance, Government of India

Honorable members are aware that the Department of Economic Affairs, Ministry of Finance, Government of India has given us a non-recurring grant-in-aid to support a Chair in Fiscal Policy for the 2012-13. We hope to get the same grant for this year too.

H. Future Programme

Training Programmes on GST Policy and Administration

Honorable members were informed during the last meeting that the zeal for the introduction of GST has dampened down considerably during recent months.



Hence, it is proposed to drop the training programme on GST for a while. Hence, no training programme was planned this year. However, the decision to hold the programme would be reviewed soon depending upon the progress on the GST front.

Publication Plans

The FPEPR proposes to bring out the following publications during the year subject to availability of resources and time:

- a. Road User Taxes in India: Issues in Policy and Governance. The FPEPR has received the consent for publishing the study from the Planning Commission.
- b. One of the studies of the FPEPR titled *Tax Reforms in India*, which was completed last year, has been accepted for publication by Oxford University Press, New Delhi. It is being brought out by them as *Handbook of Tax System in India* possibly during this calendar year.
